

NOTICE UNDER SECTION 274 OF A PERSON'S WISH TO BE A PARTY TO PROCEEDINGS

1. The McGuinness Institute wishes to be a party to *The New Zealand King Salmon Co. Ltd v Marlborough District Council* ENV-2021-CHC-074.
2. The Institute made submissions on the New Zealand King Salmon Co. Ltd's original consent applications (before a Board of Inquiry), which resulted in the consent conditions that are the subject of this declaration application. The Institute has also made submissions on the related s 127 variation applications recently heard (but yet to be determined) by Marlborough District Council (references U140294 and U140296).
3. The Institute is not a trade competitor for the purposes of Section 308C or 308CA of the Resource Management Act 1991.
4. The Institute is interested in all of the proceedings. The Institute opposes the making of the declarations sought by the New Zealand King Salmon Co. Ltd (**NZKS**).
5. The Institute disputes that the Council's previous stance (described at 2(d) of NZKS' application) is based on a misinterpretation of the relevant consent conditions (as asserted at 2(e) of NZKS' application). The Institute maintains that the conditions require compliance with individual component variables, not just compliance with an overall aggregate ES at all monitoring stations.
6. The Institute agrees to participate in mediation or other alternative dispute resolution of the proceedings.
