You are correct that conservation management strategies (CMSs) are always regional. I'll try and summarise how these things fit together:

- CMSs are required under the Conservation Act 1987, and are 10-year regional strategies that focus on outcomes for places that are special to communities and tangata whenua.
- Within the area covered by a CMS, there may be areas covered by conservation management plans (CMPs). The CMS sets the regional framework and national policy approaches, whereas the CMP sets detailed objectives.
- Conservation management plans (CMPs) are aimed at implementing the CMSs. That is why the CMP may be revoked when the CMS is approved a new CMS may require a new CMP.

I therefore don't think these terms are used any differently to what you describe. The plan is different from the strategy in terms of content, and the Ministerial approval of the new strategy simply means the old plan may need to be revoked and/or replaced.

Te Mana o te Taiao, the Aotearoa New Zealand Biodiversity Strategy 2020, on the other hand, is a national strategy for the government. It is not created to fulfil a requirement of the Conservation Act 1987, but rather as part of New Zealand's commitments under the international Convention on Biological Diversity. It is therefore not a CMS.

Q1: It looks as though 'conservation management strategies (CMS)' are always regional – is that correct?

Background: I wondered because I noted on page 66 of the TE MANA O TE TAIAO AOTEAROA NEW ZEALAND BIODIVERSITY STRATEGY 2020 (see below) mentioned the Conservation Act 1987, and that got me wondering if this GDS was a 'conservation management strategy'. Given the list below does not mention it, I assume it is not.

We note that CMP becomes redundant when the CMS is approved (see footnote). It is an interesting use of terminology given we differentiate between a plan and a strategy by its content, not by whether it has been approved by a Minister. I will think on this and might raise in our methodology. Your thoughts would be most welcome.

Your clarification unfortunately brings us into the zone where we'd have to consider <u>refusing your request in full or part,</u> due to substantial collation and research.

From recollection we actually had a similar conversation last year and we ended up with the previous scope because it was what DIA was able to collate relatively reliably. The scope we used last year, which we proposed to use again this year, already required substantial collation and research, and we ended up having to extend to answer it. The clarifications you have made below however greatly widen that scope and also make it harder to identify whether information is or is not within the scope. We would likely have to refuse at least in respect of these clarified widened aspects.

For reference, DIA doesn't hold information about department strategies centrally, it's held at the branch and business group level, and we are a large agency with many disparate functions. This means extensive manual collation and consultation is needed across all of the dozens of business groups to compile it. More importantly it means that we are relying on the interpretation of dozens of different people to produce a single set of information. In order for them to all use the same measure when collating, the criteria need to be really clear, crisp and objectively verifiable.

Below some comments on your clarifications

Clarification:

1. Please could you advise whether the scope of your current request can be mirrored from your similar request last year. I.e. documents that

a) are published online [Not correct; it is whether it is a publicly available statement or report; a characteristic of that is that it is published online]

The Department does not track or record whether a public statement or report has been made/released, via any channel, in respect of any strategy. I imagine this could include things like copies being sent to the National Library, released in OIA requests, ministerial OIA requests, written parliamentary questions, the annual review, presented at a departmental or ministerial public session or included in part of a consultation. Etc etc. This change *massively* increases the scope of your request and we would be likely to refuse in respect of all channels other than published online, as the collation and research is just too substantial. It would be impossible to anticipate how much time would be needed for it, but certainly many months. Its hard to even identify all of the possible channels that could come into play.

b) include the words <u>Strategy</u>, <u>Plan</u> or <u>Programme</u> in their title. [Not correct, it is whether it is a strategy not about the title]

I have previously (last year) tried to engage with you to clarify exactly how we are to define a strategy here. No sufficiently clear definition was able to be provided, hence we agreed to use search parameters. A large number of people from widely disparate functions are involved in collation, so we require objective criteria these people can apply. It cannot be an open interpretive exercise regarding whether they 'feel like' something probably is or is not a strategy, based on their own personal understanding of what a strategy looks like or is used for. Not only does the collation process spiral out into broad philosophical debate and become unmanageable, but the output of such open interpretive processes is invariably poor (with some people including all manner of kitchensink process items that aren't strategies, and others omitting almost everything because 'it's not a strategy, it's a plan/programme/initiative/guidance document etc'). So we need objective criteria for inclusion/exclusion.

You could consider adding further terms to the search parameter to capture other titles of things that are likely to actually be strategies.

c) are <u>public-facing</u> (i.e. about systems or services used by the public, or which are otherwise focused on the public) [Not correct, we just use publicly available statement or report]

I am not clear about what you mean. Are you saying that you now also want to include strategies focused on the internal running of the Department? Public-facing would mean that the strategy is focused on external output that affects New Zealanders. Internal strategies on the other hand might be about branch development, HR or security. These strategies would, by definition, tend not to be publicly released, so would be out of scope.

Please could you consider the above comments and advise whether you want to stick with the scope you've clarified (likely resulting in full or part refusal due to substantial collation and research), default to the scope we used in previous responses, or clarify and amend further.

As we have sought to clarify the scope of your request with you within the first seven working days of your request, when your final scope is confirmed, we will be resetting the OIA clock in accordance with section 15(1AA) of the Act.




We are now in the final part of the process. FYI, we have copied your final list below. Please do check these, as we may be missing something. Given Stats' OIA response, we have concluded that:
