Our OIA 2023/02: COVID-19 wage subsidies information on NZSX-listed companies

The Institute is currently in the process of publishing a working paper that aims to collect information on the amount of COVID-19 wage subsidy received by NZSX listed companies (as at March 2022). We are particularly interested in how the subsidy may have been disclosed within their annual reports.

Attached is an example of the dataset we are trying to develop. The columns are as follows:

- Column (i): lists the NZSX-listed company (ticker code is linked to the company's overview on NZX and company name is linked to the corresponding 2022 annual report.)
- Columns (ii) to (xi): lists the \$ amount and date of each type of wage subsidy.
- Columns (xii) and (xiii): list the \$ amount (if applicable) a company repaid to MSD and the date of repayment.
- Column (xiv): calculates the net \$ amount [total subsidy paid less repayment].
