Kia ora,

The Institute has been tracking the progress of the inaugural Long Term Insights Briefings (LTIBs) of government departments from 2021 to date. We have recorded in a table the process of development of the LTIBs. This lists key information such as: whether briefings have been created by an individual department or produced in collaboration; the time horizon of the briefings; and consultation duration. The table also provides a central location where the LTIBs, along with the consultation documents, can be accessed. The table can be found [here on our website](#).

The table is almost complete, however, there are two points of clarification needed to finalise the content regarding Te Puni Kōkiri's (TPK) draft LTIBs released in both stages of consultation ('consultation on subject matter options' and 'consultation on draft LTIB content'). We are aware that an evidence brief was released but could not find any consultation documents that may have been released for public consultation. This leads to the following questions.

Question (1): Did TPK publish a draft LTIB as part of the first round of public consultation, consulting on subject matter options?

Question (1A): If yes, are you able to provide a copy of, or link to, TPK's draft LTIB that was released as part of the first round of public consultation?

Question (2): Did TPK publish a draft LTIB as part of the second round of public consultation, consulting on the draft content of the LTIB?

Question (2A): If yes, are you able to provide a copy of, or link to, TPK's draft LTIB that was released as part of the second round of public consultation?
