Thank you for your earlier response to our questions.

We have had a thorough look at the link you provided on 23 March 2024, and have been unable to find the outstanding specific data we requested.

We appreciate this may have been unclear. To help, we have attached Table 4.1 from our upcoming *COVID-19 Nation Dates (2nd ed.)*. Would you be able to confirm the text in red font is accurate? We consider the numbers in the last two columns are on the low side (as we only have included information from press release and articles). In other words, can you provide a new table that represents the actual figures.

In addition, we would like to have the cost per vaccine dose? This could be an (i) average cost per dose, (ii) the cost for each delivery under an agreement, (iii) the initial cost (with a date) or even (iv) the latest cost (with a date). We don't want to be difficult, but we consider the cost would provide a useful context for the reader.
