To reiterate Police holds no information related to the appointment of former Commissioner Bush to the COVID Strategic Operations Command Lead. Again, we suggest that you ask the Public Services Commission if they hold the information you are seeking.

While it is true that Commissioner Bush was still employed by Police on the dates you mention, his retirement from Police on 2 April had been well signalled since the previous year, with the process for his replacement starting in mid-2019. His replacement was announced on 9 March 2020, with a transition to the new Commissioner beginning at that point.

Sorry, but I don't think the dates align. I have just spent an hour trying to work out what happened when.

From our research, the last day Commissioner Bush was working for Police was 2 April 2020. Whereas the COVID Strategic Operations Command Lead appointment occurred before the 23 March 2020.

Can you provide more information. For example, did Commissioner Bush retire early to take up the role on-or-around the 19<sup>th</sup> March – or did he undertake both roles up until the 2 April. The latter is implied in the Wikipedia entry, copied below ([https://en.wikipedia.org/wiki/Mike\\_Bush](https://en.wikipedia.org/wiki/Mike_Bush)):

**Michael Dennis Bush** CNZM is a retired New Zealand police officer. He served as the [New Zealand Commissioner of Police](#) from April 2014 until April 2020.<sup>[2]</sup>

#### Career [ edit ]

Bush joined the New Zealand Police in 1978, working at both CIB and Frontline Policing. As he progressed through the ranks he was appointed to senior roles, including Liaison Officer for South East Asia. This position was held by Bush at the time of the [2004 Boxing Day tsunami](#). He was the first New Zealand official on the scene of this incident, arriving on [Phuket](#) to assist with relief. In the [2006 New Year Honours](#), he was appointed a [Member of the New Zealand Order of Merit](#) (MNZM) for his relief work.<sup>[3]</sup> He was also awarded the [New Zealand Special Service Medal \(Asian Tsunami\)](#) recognising this work.<sup>[4]</sup>

Upon appointment to the role of Commissioner of Police in 2014, Bush made several changes focused on operational models and culture. These included the

The appointment of Commissioner Bush as COVID Strategic Operations Command Lead was administered by the Public Services Commission.

We understand it was signed by the Prime Minister and was dated 19 March 2020. We know it must exist and have been advised by someone in-the-know that it existed and that it was dated 19 March. In our book I have said:

On 19 March 2020, the Prime Minister writes to the State Sector Leadership Team establishing a COVID-19 Operations Command Centre (OCC) with Mike Bush as leader, director and coordinator of this group from 20 March.
