Adaptation Legislation: Proposed Timelines and Process

Portfolio Climate Change

On 9 December 2020, the Cabinet Business Committee:

I noted that the Resource Management Review Panel (1) and the review of t

- review of the resource management system and produced report entitled New Directions for Resource Management in New Zealand (the Report) In June 2020;
- noted that the Report had a strong climate change ocus and recommended new Managed 2 Retreat and Climate Change Adaptation legislation (adaptation legislation) to address the complex legal and technical issues associated with managed retreat and establishing an adaptation fund;
- noted that the Panel recommended to other pieces of legislation, a Natural and Built 3 Environments Act (NBA) and Scategic Planning Act (SPA), that are considered in the submission under CBC-20-30B-0120;
- noted that the submission under CBC-20-SUB-0120 includes a proposal to proceed with 4 resource management form on the basis of the Panel's recommendations although further work and refinement is needed in some areas;
- 5 noted there opportunities to strengthen outcomes for climate change adaptation within all three cosed pieces of legislation;
- note that passing adaptation legislation this term of government was covered in the Labour 6 Party manifesto;
  - **noted** there are key connections between adaptation legislation and the Strategic Planning Act and a need to keep policy linked as it is developed;
    - **noted** that there is significant new policy work required to develop adaptation legislation, which takes time and engagement, particularly for the proposals for managed retreat;
    - agreed in principle, subject to the report referred to in paragraph 10, that the overall approach to progressing the development of adaptation legislation:
    - 9.1 use the Report as a starting point for scoping and policy development;
    - 9.2 9(2)(f)(iv)
