Advancing Climate Adaptation Through the Recovery

Portfolio Climate Change

On 29 March 2023, the Cabinet Extreme Weather Recovery Committee (EWR), exercising its Power to Act in accordance with its terms of reference:

- 1 **noted** that on 27 February 2023, Cabinet invited the Minister of Climate Change, in consultation with the Minister for Cyclone Recovery, to report to EWR by the end of March 2023 on how best to advance climate adaptation issues that are not directly covered by the Cyclone Recovery Taskforce [CAB-23-MIN-0056];
- 2 **noted** that the National Adaptation Plan (NAP) is the government’s long-term adaptation strategy;
- 3 **noted** that the government is establishing foundations for the future adaptation system through the Climate Change Adaptation Bill;
