

Thank you for your email of 21 February 2025 making a request under the Official Information Act 1982 (the Act) of the Ministry for the Environment (the Ministry) for information on Climaterelated Cabinet papers from 2001-2024.

I have provided a response to each of your questions below. As part of my response, I am releasing four documents to you in full, alongside one spreadsheet created by the Ministry for your request and a filled-in copy of your spreadsheet.

This is the third request that you have submitted to the Ministry in the last ten months for information in relation to Cabinet papers. These requests have been accompanied by detailed, often large, spreadsheets which you have asked us to populate and fact check. Responding to these requests is a significant undertaking in terms of staff time and research and we have diligently completed each of these requests as soon as reasonably practicable each time.

In responding to your request below, we've tried our best to strike a balance between addressing all aspects of the request, providing a reasonable response, and meeting our obligations under the Act. In our previous responses we've answered your requests are comprehensively as possible and wish to continue to help the McGuiness Institute where possible. However, given the wide-ranging nature of the information and clarification being sought through this most recent request, we'd like to invite you to meet with us to discuss how we can best support you to gather this kind of information going forward. If you would like to take us up on this offer, please contact me via email to arrange a time to meet:

I will now address each part of your request in turn. In advance of some parts, I have provided some commentary around the information sought and our obligations under the Act in relation to the information sought. My intention here to build a joint understanding of what we are required to provide under the Act and demonstrate the areas where can potentially work together differently to support you to gather the information that you require.

Part One: Cabinet decision-making process

The Ministry is not the authority on Cabinet decision-making processes, nor are we required to form opinions, provide explanations or create new information to respond to requests for official information on this matter. Some of your questions below ask the Ministry to form opinions, provide explanations and create new information to respond to your request –

technically this information is not held by the Ministry and on this basis should be refused as such. However, in the spirit of helpfulness, we've provided responses to these questions.

Q1: Does Figure 1 below accurately reflect the standard process for Cabinet decision-making? Please provide any suggestions or additions you have to the text or stages.

Yes.

Q2: We have noticed that in most cases Cabinet papers do not have a reference number stated in the document itself. In these cases, can we assume these papers have the same reference number as the related Cabinet/Cabinet committee minute? This is what we have assumed, see excerpt of Excel in box below.

After a Cabinet paper has been considered by a Cabinet committee, a Cabinet committee summary and a Cabinet committee minute are generated for record-keeping. These have identical committee, year, and numerical code reference sections, and will only differ where the summary is labelled as SUB and the minute is labelled as MIN. The Cabinet minute has a different numerical reference code to the other two documents.

Once the paper has been considered by Cabinet, a separate Cabinet minute is generated. This uses a different numerical code to the Cabinet committee documents.

Since late 2015, when Cabinet started using the current cross-government Cabinet administration system, called CabNet, the Cabinet Office has not assigned reference numbers to Cabinet papers, only to the minutes and summary documents associated with the respective Cabinet committee and Cabinet meetings. Prior to this, Cabinet papers were assigned a reference by the Cabinet Office for each meeting that they were tabled at, and these references were not based on any of the minute or summary codes.

Please see the document "Paper references" for more information on the formatting of historical Cabinet reference codes.

Part Two: Missing information

Much of the information sought is already publicly available on the Ministry's website. In these situations, we're directing you to locate this information from our website, pursuant to section 18(d) of the Act – information sought is publicly available.

In some circumstances, you've asked us to populate columns where the information you seek is already contained within a different column in your spreadsheet. Where this is the case, we specified this for you in our substantive response below.

Q1: Filter for MFE (Col. J) and then please add missing information (identified in red text) in Col. B to K, if readily available.

All links to Cabinet papers and minutes released by the Ministry are on the Ministry's website, and the publication dates are on the respective landing pages. This information can be found by navigating to: https://environment.govt.nz/what-government-is-doing/cabinet-papers-and-regulatory-impact-statements/ and:

- under "Type", selecting "Cabinet minute" and "Cabinet paper"
- under "Topic" selecting "Climate change"
- if needed, filtering further by Publication date.

You may also find some Cabinet papers released previously under the Act at: https://environment.govt.nz/oia-releases/.

If you are unable to find a particular Cabinet paper or minute on our website, then it is likely that it was never proactively released by the Ministry. I am therefore refusing the parts of this question that request links (Columns G & I) and dates of publication (Column K) under section 18(d) of the Act as the information is already publicly available.

In Columns G and I you have also requested the title of each minute. In the cells that you have completed already, this consists of a minute code and the paper title. I have provided the minute codes in Column B as requested. As you have already added the titles of the papers into Column D, there is no new information for me to add to these columns.

In Column D, you have asked me to fill in a minute code for a number of Cabinet papers. As this information is a duplication of Cabinet committee and Cabinet minute codes in Column B, I have not added any information to this column.

In the remainder of the cells with red text in your spreadsheet, I have provided the requested information where it is held by the Ministry, in dark blue text. In some cells, I have corrected the Cabinet paper title. Some Cabinet papers have their titles tweaked before or during lodgement by Ministers, so in these instances, where I have identified a difference, I have provided you with the titles of the papers as Cabinet received them.

To find the information provided to you for Part 2, I have undergone an extensive search of the Ministry's digital archives, which do not hold a complete record of all Cabinet meeting and Cabinet paper data. Where red text remains in these cells, I have been unable to find the requested information in these archives. This includes most lodgement dates, some Cabinet committee and Cabinet meeting dates, and some Cabinet committee and Cabinet minute codes.

The missing information may be found in the Government's physical archives, but it would not be held in central repositories such as spreadsheets or tables at these locations. An attempt to locate this information would require a significant amount of time and number of documents

to be searched through. As such, I am refusing the remainder of the information requested under section 18(f) of the Act as the information requested cannot be made available without substantial collation or research.

Part Three: 14 questions on points of clarification of existing Cabinet papers

Q1-14: See 'Col. L: McGuinness Institute comment'. See yellow highlighted cells in rows 5, 12, 14, 15, 18, 20, 95, 101, 103, 105, 108 and 114 (please note some rows have more than one question).

I have provided you with a response to each of these questions in dark blue text in the respective cells of your spreadsheet. I am also releasing four documents to you in full as part of or to support four of my answers.

Please note with respect to my correspondence on Page 1 of this letter about the Ministry's responsibilities under the Act, that:

- Question 6 is an example of seeking an explanation about information that is in the purview of the Cabinet Office and not the Ministry
- Question 9 is an example of seeking an opinion of the Ministry that does not constitute official information.

Part Four: 2 questions on Cabinet papers released after May 2024

Q1: Are there any Cabinet papers missing that meet the criteria for being 'climate-related' and were published by MFE between 23 May 2024 and 31 December 2024?

Q2: If yes, could MFE add these papers in a new row at the bottom of the Excel and fill in Cols. B to K (i.e. row 115 onwards)?

The Ministry supported its ministers to lodge 31 climate-change-related Cabinet papers in 2024. Two of these Cabinet papers were lodged twice, each as different versions following revision. Nineteen of these Cabinet papers were published on the Ministry's and/or MPI's website in 2024, some of them alongside their respective Cabinet and/or Cabinet committee minutes.

In 2024, the Ministry also proactively released 28 Cabinet papers lodged between 2021 and 2023.

I have created a two-page spreadsheet to present this information to you. It contains Cabinet and Cabinet committee dates and minute references, dates of publication on the Ministry's website, and links to the publicly available documents. It may duplicate information already held by the McGuinness Institute.

Where a Cabinet paper row in the spreadsheet does not have a link, or the linked webpage does not contain the respective Cabinet committee or Cabinet minute, the respective document has not been proactively released.

This spreadsheet contains all of the information held by the Ministry to answer Part 4 of your request.

Paper references / shoulder numbers

The paper reference or shoulder numbers are located in the top right hand corner of agendas, papers and minutes. The identifier of the committee is given, followed by the year and the individual number of the document. For example:

- The shoulder number on an agenda indicates the number of a particular meeting.
 DEV Ag (02) 3 is the third agenda for 2002 for the Cabinet Economic Development Committee.
- The shoulder number on the paper identifies the individual Cabinet or Cabinet committee paper. CAB (02) 61 is the sixty-first consecutively numbered paper distributed to Cabinet in 2002. Paper numbers are allocated to papers in order of receipt.
- The shoulder number on a **minute** shows the meeting number and the agenda item number. FIN Min (02) 2/3 is a minute dealing with the third item on the second agenda for the Cabinet Committee on Finance.
- An additional agenda will have the same reference as the main agenda, but with the addition of "add 1" for example, CAB Ag (01) 16 add 1. Sometimes it is necessary for an additional agenda to be issued after the main agenda has been distributed. It will contain items that were not included on the main agenda because, for example, they were not received on time. The additional agenda will have the same reference as the main agenda, but with the addition of "add 1". It should be stapled to the main agenda, and the papers listed on it treated I the same manner as the other items on the main agenda.
- Revised versions of agendas, papers or minutes will have the same reference as the original version, but with the addition of "rev 1" – for example, DEV Ag (01) 3 rev 1.

National Adaptation Plan scope and approach – Final Cabinet Paper and talking points

Purpose

- This briefing attaches the final Cabinet paper National Adaptation Plan scope and approach.
 It outlines the key changes made to the paper based on agency and Ministerial feedback.
 Both a track changed (Appendix 1) and clean version (Appendix 2) of the Cabinet paper are attached.
- We seek your direction on the vision and approval on other points of clarification today for the paper to be lodged by 10am on Thursday 18 March and considered at the Cabinet Economic Development Committee (DEV) meeting on 24 March. Talking points for the Committee meeting are also attached (Appendix 3) along with the Cabinet paper appendices (Appendices 4-6).

Summary of changes

- We received feedback from 15 agencies. In general agencies support the paper, however some, particularly those identified as responsible for leading outcome areas, expressed concern about resourcing the next phases of work. Many highlighted their other work to reduce emissions.
- 4. The feedback from Ministerial consultation focussed on the specific language of the vision, clarity about the Te Ao Māori approach and engagement with iwi and Māori that will be taken and a recommendation that the guiding principles should sit within one category to apply to both development and implementation of the Plan. This was consistent with comments received from departments.
- 5. The main feedback received was in relation to the vision and the need to ensure this maximises opportunities for action. Other feedback included points of clarification.

The vision (paragraph 32)

Feedback highlighted concern that the direction set by the vision could limit adaptation options and emphasise short-term action. The terms within the vision most commented on are bolded in the statement below. Feedback received and suggested alternatives are outlined in Table 1.

Our people, places and systems are resilient, thriving and **able to adapt** to the effects of **unavoidable** climate change in **a fair, lowest cost** and **ordered manner**.

Table 1: Summary of feedback on vision and suggested alternatives

Feedback received	Recommended alternative
Able to adapt: Could be stronger so the vision strives for continued action on adaptation, not the just ability to adapt.	Continuously adapting
Unavoidable: Could limit the scope and aspiration of the vision and create confusion. Suggest removing in recognition that we may fail to avoid some of the avoidable impacts of climate change and will need to adapt to all impacts that occur.	Omit from the vision

Feedback received	Recommended alternative
Fair : Questioned the application of this term in respect to adaptation. Fair means treating people equally, but some will need more help than others. Preference for use of 'equitable'.	Equitable
Lowest cost: Creates a risk that short-term costs become the focus. This could result in higher costs in the long-term, lead to maladaptation, or further exacerbate risks to groups or values disproportionately impacted by climate change. E.g. For transport infrastructure, effective and long-lasting adaptation solutions are often not the 'lowest cost' options, but they can be considered cost-effective over the long-term.	Fiscally-responsible (note this is the language provided by your office on 16 March)
Ordered manner: Uncertainty about meaning, and concern this could suggest ranking or priority treatment for some over others.	Planned manner

We seek direction on your preferred vision statement in response to the feedback

7. We recommend the vision is revised due to the number and consistency of comments received from both departments and Ministers. An alternative option is provided below for your consideration:

Our people, places and systems are resilient, thriving and continuously adapting to the effects of climate change in an equitable, fiscally-responsible and planned manner.

- The attached Cabinet paper retains the original vision you directed us to include:
 - Our people, places and systems are resilient, thriving and able to adapt to the effects of unavoidable climate change in fair, lowest cost and ordered manner.
- 9. If you agree to revise the vision we will update the Cabinet paper and Appendix 1 of the Cabinet paper (Appendix 4 attached).

Points of clarification

One category of principles to guide the Plan's development and implementation (paragraph 33)

- 10. Feedback highlighted that applying the principles for implementation will only be possible if scope is provided during development of the actions. For example, it would be difficult to apply nature-based solutions to the implementation of actions that did not allow for such solutions in how they were designed, or apply matauranga Māori in implementing the plan if none of the actions were grounded in traditional knowledge.
- 11. The paper has been updated to include one category of principles to avoid this confusion and guide both development and implementation of the Plan. This increases the likelihood of application of these principles across all outcome areas. The changes can be found in paragraph 33 and in Appendix one of the paper.

Greater clarity of the principles (paragraph 33)

12. Feedback suggested revision of the principles so their intent was clearer, and to ensure consistency with language throughout the paper.

- 13. We recommend the following changes (bolded below) are made to clarify the intent of the principles. These are found in **paragraph 33**.
 - <u>Think long-term</u>: Take a long-term, **intergenerational** perspective **that spans political**, **planning and financial cycles**, **to** plan for a changing climate.
 - <u>Partnership</u>: Adapt together, in partnership with iwi, hapū, **Māori**, and all New Zealanders ara whakamua.
 - Adjust as we go: To enable flexibility in decision making, design actions and decisions to be re-visited and adjusted as circumstances change.
 - <u>Nature-based solutions Ecosystem-based approach</u>: Use Consider using biodiversity and nature-based ecosystem services to increase resilience.
 - <u>Place-based approach</u>: Adapt locally enable local communities to prepare for the unique climate risks and opportunities they face, while ensuring the right type of intervention is used at the right stage, scale and location.

Engagement with Treaty Partners and impacts on iwi/Māori (paragraphs 47, 59, and 62-65)

- 14. Text has been revised to more clearly:
 - a. acknowledge that engagement with Ihirangi is not intended to comprise engagement with all iwi, hapu and Māori (see paragraphs 48)
 - b. signal that the breadth of engagement with iwi, hapu and Māori is required and will be planned (see paragraphs 58 and 59)
- 15. On the recommendation of Te Puni Kokiri, the implications of climate change on Māori has been brought into the Population Implications section of the paper (paragraphs 62 to 65). This information now sits within Table 2 alongside other population groups (see paragraph 64).

Two new groups identified as populations that may be disproportionately impacted (paragraph 64)

16. 'Pacific Peoples' and 'Rural Communities' have been included as population groups with particular sensitivity to the impacts associated with climate change. This reflects the breadth of outcomes within the Plan that apply to these groups.

You provided a copy of your spreadsheet and requested the following:

Part One: Cabinet decision-making process

- Q1: Does Figure 1 below accurately reflect the standard process for Cabinet decision-making? Please provide any suggestions or additions you have to the text or stages.
- Q2: We have noticed that in most cases Cabinet papers do not have a reference number stated in the document itself. In these cases, can we assume these papers have the same reference number as the related Cabinet/Cabinet committee minute? This is what we have assumed, see excerpt of Excel in box below.

Part Two: Missing information

• Q1: Filter for MPI (Col. J) and then please add missing information (identified in red text) in Col. B to K, if readily available.

Part Three: Questions on Cabinet papers released after May 2024

- Q1: Are there any Cabinet papers missing that meet the criteria for being 'climate-related' and were published by MPI between 23 May 2024 and 31 December 2024?
- Q2: If yes, could MPI add these papers in a new row at the bottom of the Excel and fill in Cols. B to K (i.e. row 115 onwards)?
