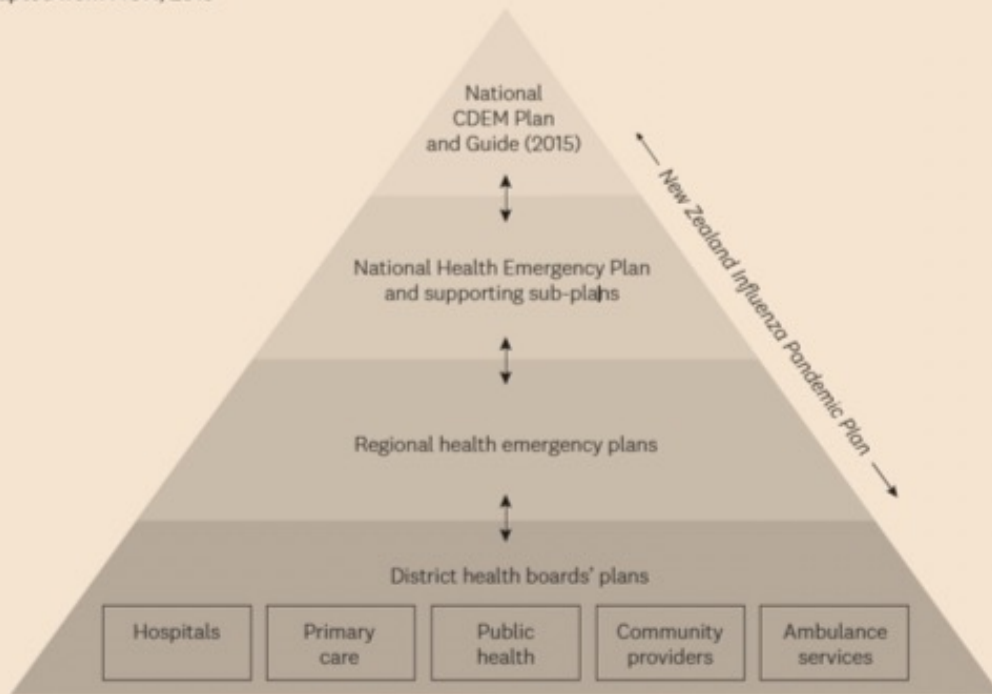
Please find below two additional questions that relate to our previous OIA (your reference H2026079431).

**Figure A1.13: Health emergency management framework documents, October 2015 and March 2026**

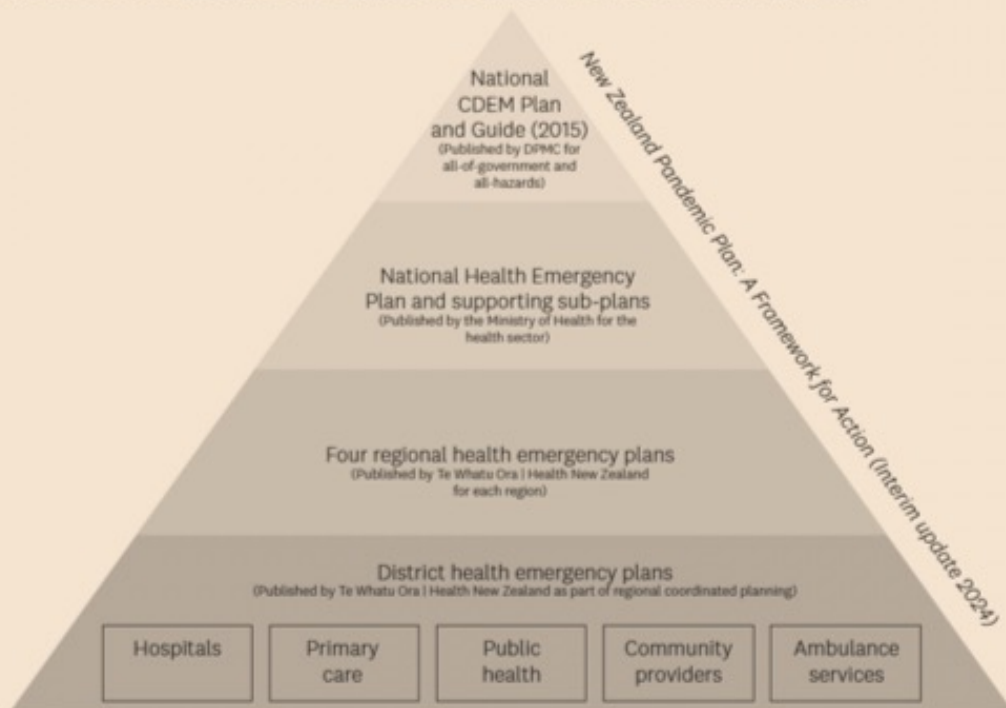
**Figure A1.13(a): Health emergency management framework documents, October 2015**
